L. Miller asked what the difference is between the dean of students job and what D. Maurice was doing as vice principal. D. Maurice said the dean of students position is more limited in how much planning, supervision and evaluation is part of it. It is more focused on student management and coordination with student teams. Work she used to do as vice principal involving teachers, planning for faculty meetings, and the budget won't be on the dean of students' plate. C. Gallagher said the focus is on student behaviors and successes.

The motion was passed.

C. McFarlane asked the committee to approve hiring Melissa Barnier as a second grade teacher for Eden Central School at the base rate of \$40K. <u>C.
