C. McFarlane said the recommendation is to hire Penny O'Neil as the LNSU/CES Special Education Long Term Substitute at a salary of \$58,472, pro-rated based on the term. Ms. O'Neil will need a provisional license.

K. Orost moved and C. Fagnant seconded to hire Penny O'Neil as the LNSU/CES Special Education Long Term Substitute at a salary of \$58,472, pro-rated based on the term, and the motion passed.

C. McFarlane said the recommendation is to hire Brianna Hypolite as the LNSU/JES Special Education teacher at a salary of \$50,876. She will be filling the position vacated by Emily Marcoux.

K. Orost moved and C. Fagnant seconded to hire Brianna Hypolite as the LNSU/JES Special Education teacher at a salary of \$50,876 and the motion passed.

C. McFarlane said the recommendation is to hire Teri Sibenaller as the LNSU/CES PreK Special Education teacher at a salary of \$41,000. She will be replacing Arielle Powers and will need a provisional license.

K. Orost moved and C. Fagnant seconded to hire Teri Sibenaller as the LNSU/CES PreK Special Education teacher at a salary of \$41,000 and the motion passed.

C. McFarlane said the recommendation is to hire Salina-Mae French as the .5 LUHS Art teacher at a salary of \$41,000, pro-rated based on FTE. Salina-Mae is a graduate and did her student teaching at Lamoille and is excited to be a teacher at Lamoille North. This is a new position based on student need and will be a one year position. She will need a provisional license.

K. Orost moved and C. Fagnant seconded to hire Salina-Mae French as the LUHS Art teacher at a salary of \$41,000 and the motion passed.

C. McFarlane said the recommendation is to hire Robert Maher as the LUMS Social Studies teacher at a salary of \$41,000. Robbie will be replacing David Baird.

K. Orost moved and C. Fagnant seconded to hire Robert Maher as the LUMS Social Studies teacher at a salary of \$41,000 and the motion passed.

C. McFarlane said the recommendation is to hire Andrew Iwaskiewicz as the JES 5th Grade teacher at a salary of \$46,376. Andrew was a teacher at JES for four years under emergency and provisional licenses so we will need to request a special waiver for another provisional license.

K. Orost moved and C. Fagnant seconded to hire Andrew Iwaskiewicz as the JES 5th Grade teacher at a salary of \$46,376, pending the waiver approval.
